**TERMS AND CONDITIONS**

1. Information on how to enter and the prize(s) form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. Entry is only open to Australian residents aged 18 years or over.
3. Employees (and their immediate families) of the Promoter, Participating Stores (defined below) and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1<sup>st</sup> cousin.
4. Entries into the promotion open on 13/04/2026 and closes at 11:59pm AEST on 26/04/2026 (“**Promotional Period**”).
5. A “**Participating Store**” is any The Bottle O store in Australia that advertises the promotion and stocks the Eligible Product (defined below) during the Promotional Period.
6. To be eligible to enter, individuals must spend \$30 or more on any Fireball product (“**Eligible Product**”) at a Participating Store and obtain a purchase receipt during the Promotional Period (“**Qualifying Transaction**”). If an individual does not automatically receive a purchase receipt, it is their responsibility to request one from staff.
7. To enter, individuals must then scan the QR code featured on advertising material located in store, follow the prompts to the promotion entry page, input the requested details, upload a copy of their purchase receipt and submit the fully completed entry form during the Promotional Period.
8. Multiple entries permitted, subject to the following: (a) only one (1) entry permitted per Qualifying Transaction regardless of the amount spent on Eligible Products in excess of \$30; and (b) each entry must be submitted separately and in accordance with entry requirements.
9. Entrants must retain a copy of their purchase receipt(s) for all entries as proof of purchase. The Promoter, reserves the right, at any time, to verify the validity of entries and entrants (including an entrant’s identity, age and place of residence) and reserves the right, in its sole discretion, to disqualify any individual who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the promotion. Errors and omissions may be accepted at the Promoter’s discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. The Promoter’s legal rights to recover damages or other compensation from such an offender are reserved.
11. Incomplete or indecipherable entries will be deemed invalid.
12. If there is a dispute as to the identity of an entrant, the Promoter reserves the right, in its sole discretion, to determine the identity of the entrant.

The Promoter may draw additional reserve entries and record them in order in case an invalid entry or ineligible entrant is drawn. The winner will be notified by email within two (2) business days of the draw. 14. The Promoter's decision is final and no correspondence will be entered into.
15. The first valid entry drawn will win a trip for two (2) adults to their preferred destination as below:
  - a) **Option 1:** Jet skiing on the Gold Coast. This option is valued at up to \$5,000 depending on date and point of departure and includes:
    - 2 x return economy airfares from winner's nearest capital city to the Gold Coast, QLD (only provided if the winner resides outside of QLD).
    - All airline and airport taxes;
    - Private return transfers from the airport to the accommodation;
    - 2 x nights 4 star accommodation in Gold Coast (twin share or similar) with breakfast includes; and
    - Jet ski safari 90 minute tour for two (2) adults.
  - b) **Option 2:** White water rafting and bungy jumping in Cairns, QLD. This option is valued at up to \$5,000 depending on date and point of departure and includes:
    - 2 x return economy airfares from winner's nearest capital city to Cairns, QLD (only provided if the winner resides outside of QLD).
    - All airline and airport taxes;
    - Private return transfers from the airport to the accommodation;
    - 2 x nights 4 star accommodation in Cairns (twin share or similar) with breakfast includes;
    - Bungy jump for two (2) adults. A minimum weight requirement of 45kg applies to this element.
    - Barron River rafting for two (2) adults.
  - c) **Option 3:** Sky diving over Great Ocean Road, VIC. This option is valued at up to \$5,000 depending on date and point of departure and includes:
    - 2 x return economy airfares from winner's nearest capital city to Melbourne VIC (only provided if the winner resides outside of VIC).
    - All airline and airport taxes;
    - Private return transfers from the airport to the accommodation;
    - 2 x nights 4 star accommodation in Melbourne (twin share or similar) with breakfast includes;
    - Skydive for two (2) adults, including: tandem skydive from up to 15,000ft over the Great Ocean Road Shared; bus pick up and drop off from Southbank VIC; and up to 60 seconds of freefall. Surcharges may apply if the winner weighs 94kg or over.
16. Spending money, meals, insurance, transport to and from departure point, additional transfers, items of a personal nature, in-room charges and all other ancillary costs are not included.
